Client will be responsible for providing this information by filling out the questionnaire below. Without this information, Company will fill out submission forms to the best of their knowledge about the client but cannot guarantee the accuracy of the information.

2. Company respects the privacy of the client and acknowledges this information is not to be shared or used for any other purpose than to fulfill this agreement.

3. Client acknowledges the following with respect to search engines:

- Company has no control over the policies of search engines with respect to the type of sites and/or content that they accept now or in the future. Client site may be excluded from any directory at any time at the sole discretion of the search engine or directory. Some search engines and directories may take as long as 2 to 4 months, and in some cases longer, after submission to list your site.
- Occasionally, search engines will stop accepting submissions for an indefinite period of time.
- Occasionally, search engines will drop listings for no apparent or predictable reason. Often listing will reappear without any additional submissions.

- Some search directories offer expedited listing services for a fee. Company will not submit to directories that require additional fees without the consent of Client. Client is then responsible for expedited service fees, example Yahoo, unless otherwise noted in the package Client purchases.
- Company cannot guarantee page rank.
- Results do not happen immediately after the website is complete. The website may start producing results within days but may take 2-3 months of upon finalization.
